Solari Advisors Privacy Policy Statement

Dated June 19, 2018

This Privacy Policy Statement discloses the privacy practices for Solari Investment Advisory Services, LLC ("Solari Advisors") and our website; http://www.solariadvisors.com.

This Privacy also covers information collected from investment advisors and other companies to which we provide products and services. It will notify you of the following:

What information we collect; With whom it is shared; How it can be corrected; How it is secured; How policy changes will be communicated; and

How to address concerns over misuse of personal data.

We understand and respect the privacy of non-public personal information we receive at Solari Advisors, including from this website.

This Privacy Policy Statement applies to our relationship with you if you are an investment advisor or financial institution that obtains investment screens or research services from Solari Advisor for use in your advisory business.

RECOGNITION OF EXPECTATION OF PRIVACY

You regard your business information as private, and so does Solari Advisors. Because we do not sell or share your information with third parties not associated with services we conduct for you or on your behalf (except as required by law), it is not necessary that you to tell us not to share your private information.

INFORMATION WE COLLECT

We are the sole owners of the information collected on this site. We do not collect information on our website other than default log information in our web server software (e.g. IP address, time of access and where the visitor went on the site as well as type of browser and computer platform.)

We have access to/collect information that you voluntarily give us via email, mail or other direct contact from you.

If we provide you with products and services, in the course of doing business with you, Solari Advisors may collect non-public information about you from a variety of sources:

Contact information for your company and employees;
Information about your business and investment operations;
Suggestions, questions and input you may have provided us by email.

We prefer that any private digital information you send to us be password protected. We welcome the use of your secure digital system if available for communication. We believe that digital systems are inherently insecure and may be unstable. We therefore prefer your provide confidential information by phone or by US mail or courier.

We request that you not share confidential data about your individual clients with us. In the event that you must do so, we request that you send us this data in hard copy by US mail or courier.

MAINTENANCE OF INFORMATION

Solari has internal procedures designed to maintain accurate records concerning your information. Should you ever believe that our records contain inaccurate, incomplete or non-current information about you, please notify us. We will respond to requests to correct the information in a timely manner.
